AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR IGNACIO CREEK

I, CATHERINE L. GOWDY, am the Secretary of Ignacio Creek Homeowners' Association, Inc., the "Association" referred to in that certain DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR IGNACIO CREEK recorded on March 11, 1974 in the Office of the Recorder of the County of Marin, as Instrument No. 7955, in Book 2771, at Page 676, as amended of record on April 1, 1978, in Book 2778 at page 8, on May 28, 1974 in Book 2798 at Page 512, and on December 23, 1991 as Instrument No. 91-080447 which instrument, as so amended, is hereinafter sometimes referred to as "the Declaration." I hereby certify as follows:

- 1. that there is now only one class of members of the said Association, that is, "Class A" members, under the provisions of Article III, Section II of the Declaration, the "Class B" memberships therein mentioned having been converted to "Class A" memberships under the terms of said provisions.
- 2. that the signatures set forth below are those of Owners constituting not less than seventy-five percent (75%) of the voting power of the association.
- 3. that at a special meeting of Owners (as that term is defined in the Declaration) of the Association, held on March 18, 1993 seventy-five percent (75%) of the owners present, in person or by proxy, approved the following amendment to the Declaration:

Section 1 of Article IX of the Declaration is hereby deleted and, in its place, a new Section 1 is inserted, as follows:

"Section 1. Residence Insurance. The Association shall have the duty to purchase, carry and at all times to maintain in force, fire insurance with extended coverage endorsement covering all of the Residence Lots, the improvements thereon and appurtenant thereto, for the interest of the Association and of all Owners and their Mortgagees, as their interests may appear, in such amounts and with such endorsements and coverage as shall be considered good sound insurance coverage for properties similar in construction, location and use. Such insurance will be in an amount which shall be equal to the maximum insurable replacement value, excluding foundation and excavation costs, as determined annually by the insurance carrier."

The introductory language of Section 2 of Article IX of the Declaration, consisting of the words "If all or any portion of any residence lot is damaged or destroyed by fire or other casualty, then the following rules shall be applicable:" is

hereby deleted and, in its place, new language is inserted, as follows:

"If all or any portion of any residence is damaged or destroyed by fire or other casualty (i) which is actually covered by a policy or policies of insurance then in effect in favor of the Association, (ii) the involved insurance carrier(s) acknowledge(s) such coverage, any dispute with regard to which having been undertaken by or at the expense of the affected Owners, (iii) and the cost of repair of the damage or destruction does not exceed \$10,000 per residence; then, subject to the following provisions of this Article IX, Section 2, the Association will effect (or at the Association's option, reimburse the owner for) the repair of such damage or destruction; provided, however, that the owner or owners of the affected residence or residences, and not the Association, shall bear the expense of any deductible or deductible amounts under such policy or policies of insurance, and the Association shall have the right to reimbursement from such owner or owners, enforceable by special assessment, for the amount of such deductible which may have been borne by the Association. or any portion of any residence is damaged or destroyed by fire or other casualty and the cost of repair of the damage or destruction does not exceed \$10,000 per residence but the damage or destruction is either (i) not covered by a policy or policies of insurance then in effect in favor of the Association, or (ii) the involved insurance carrier(s) fail or refuse to acknowledge(s) such coverage, any dispute with regard to which having been undertaken by or at the expense of the affected Owners; then the Association shall have no obligation to effect or to reimburse the owner for the cost of repair of such damage or destruction. If all or a portion of any residence is damaged or destroyed by fire or other casualty and the cost of repair of the damage or destruction exceeds \$10,000 per residence, then the following rules shall be applicable:"
