AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR IGNACIO CREEK

I, Mikhail Lotosh, am the Secretary of Ignacio Creek Homeowners' Association, Inc., the "Association" referred to in that certain DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR IGNACIO CREEK recorded on March 11, 1974 in the Office of the Recorder of the County of Marin, as Instrument No. 7955, in Book 2771, Page 676, as amended of record on April 1, 1978, in Book 2778 at page 8, on May 28, 1974 in Book 2798 at Page 512, on December 23, 1991 as Instrument No. 91-080447, and on May 13, 1993 as Instrument No. 93-038227, which instrument, as so amended, is hereinafter sometimes referred to as the "Declaration." I hereby certify as follows:

- 1. That there is now only one class of members of the said Association, that is, "Class A" members, under the provisions of Article III, Section II of the Declaration, the "Class B" memberships therein mentioned having been converted to "Class A" memberships under the terms of said provisions.
- 2. That the signatures set forth below are those of Owners constituting not less than seventy-five percent (75%) of the voting power of the association.
- 3. That commencing at the Annual Meeting of Owners (as that term is defined in the Declaration) of the Association, held on November 15, 2016, and thereafter, seventy-five percent (75%) of the Owners of Residence Lots approved the following amendments to the Declaration:

Section 1 of Article IX of the Declaration is hereby deleted and, in its place, a new Section 1 is inserted, as follows:

"Section 1. Residence Insurance. The Association shall have the duty to purchase, carry and at all times to maintain in force, fire insurance with extended coverage endorsement covering all of the Residence Lots, the improvements thereon and appurtenant thereto, for the interest of the Association and of all Owners and their Mortgagees, as their interests may appear, in such amounts and with such endorsements and coverage as shall be considered good sound insurance coverage for properties similar in construction, location and use. Such insurance will be in an amount which shall be equal to the maximum insurable replacement value, costs, as determined annually by the insurance carrier."

Section 3 of Article X of the Declaration is hereby deleted and, in its place, a new Section 3 is inserted, as follows:

"Section 3. Term; Amendment. The covenants and restrictions of this Declaration shall run with and bind the land, for a term of thirty-five (35) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years. This Declaration may be amended by the vote or written assent of seventy-five percent (75%) of each class of Owners, as herein provided; the amendment shall become effective upon recordation of an instrument executed by the President or Secretary of the Association setting forth the amendment and certifying that such vote or written assent has been attained. Provided, however, that such instrument shall not be recorded sooner than the seventh (7th) calendar day following the attainment of such vote or written assent, during which period all Owners shall have been afforded the opportunity to review the signatures or other evidence of such vote or written assent, by means of their having been posted on the Association website, or being given substantially equivalent exposure, and having been made available for inspection at the Association office."


